Students are required to successfully complete the didactic and laboratory of 219 hours and an externship of 160 hours. Total clock hours of 379. Upon successful completion of the course with the appropriate number of hours required, in addition to a cumulative grade point of B (80%) in midterm and final exam. Student will be awarded the certificate of completion. All fees must be paid in full. This program will prepare you to take the Certified Pharmacy Technician exam (CPhT) through the Pharmacy Technician Certification Board. There are no prerequisites for this program.
